Valuer general's Valuation Lists 1927-1980 loose leaf in binders.</p> <p>Valuation and Rate Analysis Books 1970 – 1975 and Rates Summary Book 1977 are bound, handwritten volumes.</p> <p>Valuer General Valuations for 1972 are computer printouts in binders.</p>		
<b>Content Description :</b>		
<p>Series comprises valuation, assessment and rate books for Bowral Municipal Council. Assessment, Rate and Valuation records are records of property taxes levied by local council. Information in these records may vary but can include the name of owner or occupier of dwellings and businesses, location of buildings, improvements to the property, historical evidence of former land use practices and property valuations.</p> <p>Assessments were undertaken annually by Council to determine rates payable. Council Valuations replaced Assessments but served the same function.</p> <p>Rate Notices annually compiled by Council to record name of rate payer, payments due, paid or in arrears for each property. Revenue raised by each street or ward also included.</p> <p>Valuation Lists compiled by New South Wales Valuer General replaced Council Valuations.</p>
